- 1. I forever release Ron Ingels, Lone Star Select Shooting Team, LLC (Lone Star) from all liability for negligence of any type and waive any claims for personal injury, death, damages, or other losses of any kind, regardless of how or by whom such loss may be caused, which occur to me, my guests, or my property while participating in the activities offered. This release and waiver shall apply and extend to Ron Ingels, RPM Shooting, its employees, directors, officers, insurers or agents.
- 2. I assume all risks of personal injury, death, damages, or losses of any type or for any reason that occur while taking part in activities offered by Lone Star or while at any facility whether or not such risks are known or unknown, or result from the negligent actions or non-actions of RPM Shooting and Lone Star Select Shooting Team, its agents or employees, or the negligence of others who are on the Premises. Those risks include, but are not limited to, risks related to the discharge of firearms, the firing of live ammunition by myself and others, the design of, or conditions of the Premises or the design of or conditions of the facilities located on the Premises.
- 3. I forever release, indemnify, and hold harmless Ron Ingels, Lone Star Select Shooting Team, LLC and/or any of their employees, directors, officers, insurers or agents from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with the discharge of firearms, the firing or ricochet of live ammunition by myself or others, presence at, conditions of, and use of the facilities located on the Premises or the design or condition of the facilities located on the Premises including, without limitation, the costs of court, attorney's fees or other costs or expenses incurred in connection with defending any such claim, demand or lawsuit.
- 4. If signing as a parent, I am authorized to act on behalf of the minor named in this agreement.

Range Safety Rules

- Eye and Ear protection are MANDATORY at all times.
- NO ALCOHOL or DRUGS are allowed on the range at any time.
- Shooter shall know and understand SAFE operation of all firearms in use.
- Shooter shall keep all firearms pointed in a safe direction.
- Firearms shall be loaded/unloaded with the barrel pointed down range.
- Shooter's finger shall remain off the trigger until ready to shoot.
- Firearms shall remain unloaded until ready to shoot.
- Shooter shall obey all posted signs and all range rules.

- Shooters shall ensure that only correct ammunition is used in a firearm. No larger than 7 1/2 shot is allowed
- Shooter shall remain aware of the target and what is beyond.

Best Practices

- 1. Treat every firearm as a/ways loaded.
- 2. Don't let the muzzle of your firearm cover anything which you don't intend to shoot.
- 3. Keep your finger OFF the trigger until your sights are on the target.
- Always be sure of your target and everything beyond it.
 THINK first. . . Shoot SECOND!
